The importance of ensuring multi-benefits through these projects and future programs that centers indigenous concerns, and tenants. Water sovereignty for indigenous folks through these projects (land back/water back efforts). Not that it was missing, but to ensure that the issue of people who are experiencing housless-ness are supported instead of criminalized and further pushed out and neglected. In terms of multibenefits, they were wondering if this work could also uplift the importance of a transition from fossil fuel to natural energy, and specifically named zero emission transportation. In terms of ideas to implement these concerns, members suggested drought specific support/infrastructure for low-income communities of color; a county certified list of native/drought tolerant plants that community members can refer to and the idea of a program that gave funds to community members who used the list to change the landscape in their homes in addition to other water conservation elements in their home; and programs for rainwater in apartment complexes. There are funds for homes but less support for tenants in apt buildngs, this can help utilize space in a smart way for water. In terms of greenspaces, there has been the normalization of cutting trees when an issue arises. A community member shared this experience: *There used to be a tree behind my apartment and it got full of honeybee's and my mom called Housing authority to get a beekeeper but a beekeeper never showed up and instead they sent a pest exterminator and the tree was taken off from its roots, now we have no tree(s) around like there are barely any around the apartments.* The idea came up of no net loss to be incorporated within projects and programs i.e. if you cut a tree, plant a tree; plant 10 trees!

Education is also desired on best practices for cities to conserve water; for context member shared concerns on wasteful practices they've seen from their city, i.e. not maintaining & fixing city leaks in the streets or parks; water rates and high costs in Lynwood; broken wells or infrastructure, irrigation system. Is there any assistance for homeowners who have broken or leaking water pipes? Water bill was \$2k! Why weren't they notified? Do programs already exist to assist homeowners with their own water piping and monitoring of water?

They would like for when large trees are felled that they be replaced with other large trees and for there to be maintenance of an urban forest. The meeting was held at TreePeople's headquarters, and included a tour of the educational La Kretz Urban Watershed Garden. The group wanted to know how to incorporate features like the sustainable house demonstration and find out how to incorporate stormwater capture features such as bioswales, rain barrels, and rain gardens on campus. There was a list of schools that they felt would be great to pilot some of these school greening initiatives: Burbank High School, Efon, John muir Middle School, Miller, and MLK- This is where families at the middle school can pilot tree plantings.

On Friday July 8th, 2022, Mujeres de la Tierra hosted a Platica "Conversation" community with community members and residents from Elysian Valley to "ground truth" results of the Needs Assessment. While MDLT began this gathering by sharing the presentation and messaging provided by TreePeople for this specific WaterTalks meeting, this Platica centered around Elysian Valley resident's needs and concerns relating to water and water quality. This gathering, which was organized and facilitated with support from a local community organizer, allowed for the safe and open sharing of community member's concerns relating to water and water quality, beyond those included in the WaterTalks Survey and Needs Assessment. Through small group and then a larger group Platica, participants (approximately 27) shared, concerns relating to regional water storage, water use/watering restrictions, notable odors in water from the tap, and the effect of home piping on municipal water quality. As a result of our gathering, at least 15 additional WaterTalks surveys were completed (online). Of note: In light of the intensifying policies and enforcement, will the wealthy be held accountable for their water use and lawns? Questions and concerns about the language used in LADWP Water Testing data reports; how can the general public understand it if it isn't written clearly? Strong desire for more information/transparency from the city on water. Most do not trust the tap water in their homes, and throughout the city (public water), so they resort to buying bottled water and using filters (fridge, Brita, tap filter). Public water stations are a good convenience that should be more present; however, participants want more information on the provider, maintenance, etc. They would be even more likely to use them if they had more information.

On Saturday July 16th, 2022, Mujeres de la Tierra (MDLT) hosted a Platica "Conversation" with community members and residents from Glassell Park to discuss results of the Needs Assessment. This Platica was held at Juntos Family Park (3135 Drew St. Los Angeles, CA 90065) and was attended by 32 participants, including men, women and children. Moreover, this community meeting was multigenerational, with attendees including children, adults, parents and grandparents. This meeting was hosted in Spanish, as recommended by the local community organizer who supported the development, outreach for and implementation of this community meeting. Because meeting materials and information resources, provided by TreePeople, are 1) designed for indoor presentation (i.e. PowerPoint presentation) and 2) are almost exclusively available in English, MDLT had to adapt and develop meeting materials to allowing the effective sharing of the Needs Assessment with Glassell Park residents outdoors and in Spanish. Using translated meeting materials (English to Spanish), printed info graphs and interpretive displays, MDLT was able to effectively share/discuss results of the Needs Assessment with community members from Glassell Park.

Because this Platica was hosted in Spanish, attendees expressed feeling comfortable sharing their input on results of the Needs Assessment. Moreover, participants openly expressed and shared their needs and concerns with the MDLT team, as they "felt that that they would be heard". Together, a 1 hour WaterTalk turned into a 2 hour Platica "Conversation" about Water – a need, resource and commodity in the Glassell Park community. Also of note: 99% of participants obtain and pay for drinking water from water machine or water stores, because they don't trust the quality of municipal drinking water. Additional water quality data/information was requested (in Spanish) as a part of the Dashboard. Verbal response polling showed that results of the Needs Assessment were overall (90%) accurate and congruent with the needs and concerns of Glassell Park community members.
